DO YOU QUALIFY FOR WIC?

Applicants must meet all of the following eligibility requirements.

RESIDENTIAL REQUIREMENT

You must live in the State in which you apply, but do not need to be a U.S. citizen.

CATEGORICAL REQUIREMENT

You must be one of the following:

- A pregnant woman
- An infant or child up to five years old
- A mother of a baby up to six months old
- A breast feeding mother of a baby up to 12 months old

INCOME REQUIREMENT

You must have income at or below an income level or standard set by the State agency (see chart below), or be determined automatically income-eligible based on participation in certain State-administered programs, including SNAP, Medicaid, and TANF.

NUTRITION RISK

- Medically-based risks (designated as "high priority") such as anemia, underweight, maternal age, history of pregnancy complications, or poor pregnancy outcomes
- Diet-based risks such as inadequate dietary pattern

Nutritional risk is determined by a health professional such as a physician, nutritionist, or nurse, and is based on Federal guidelines. This health screening is free to program applicants.
